CCR stands for “Covenants, Conditions and Restrictions.” If you own property in a subdivision with a CCR, you have a live, valid civil contract with the other property owners in your subdivision that governs what development is allowed on your property and theirs.

Since these are private civil contracts, the City has no role or responsibility in implementation and no record of them. Importantly, CCRs override any development plans or permits granted by the City that would violate terms of a CCR.

CCRs vary by subdivision, so the limitations and permissions may be very different from one to another. You may be protected from unwanted development around you, or may be free to develop your property as you wish even if your neighbors don't like it.

How to find out if you have a CCR

To learn whether you have a CCR you must first know your subdivision name (your “plat”). To learn your subdivision name, [click here](#) to go to the Lane County map. On the Table of Contents menu to the right, check “Plats” and uncheck everything else. Now enter your address in the address field (upper left). Your subdivision name will be displayed in red on the map. (You may need to close the Table of Contents box to see it.)

Once you know your subdivision, find it listed in alphabetical order on the **SEN CCR Database** below. If the column next to your subdivision name says “Yes”, click the live link to see the public record of your CCR on the Western Title & Escrow website. **Please note:** a few subdivisions have CCRs that are not included there. If the list below says “None” for your subdivision, you may still have one, so see your property deed and title for the final answer.
